PROFESSIONAL ENGINEERING (PE) GRANT TO ANOTHER PROJECT

EXECUTIVE SUMMARY:

On June 7, 2022, the Port Authority received \$40,000 in FY23 PE funds from the State of Missouri (MO). Resolution 22-PT-19 approved receipt and use of this grant for the Municipal River Terminal paving project. The Authority received additional funds for the paving project and is therefore requesting authorization to use the \$40K in PE funds for a different project.

BACKGROUND:

The city's South Refuse Division occupies riverfront land with mooring options along the river and a Union Pacific Railroad main line on the west side of the property. Because the city's trash collectors don't need barges or trains, the Authority is working to relocate South Refuse to a central city location to clear the river site for maritime commerce. Exhibit A for the South Riverfront Redevelopment Project shows the current South Refuse site at 4230 South 1st Street and the main Refuse Division, 1200 Central Industrial Court, to which South Refuse will move.

4230 South 1st Street, a trash-transfer facility, has a no-longer-used incinerator, smaller buildings, trucks and other equipment, and employee parking. The Authority will need engineering services for surveying, environmental assessments, and site prep. Phase I will comprise razing the incinerator. After clearing the site in Phase II, the Authority will issue an RFP for prospective tenants for land and/or mooring leases. Four companies the Authority has talked to about the project are interested in a public/private partnership for Phase III: redeveloping this parcel for a shipping facility.

In June the Authority presented this project at a MO Port Authorities Association meeting and was allocated \$5.7M in federal ARPA dollars to be administered by the MO Department of Transportation. The ARPA grant will require a local match but the \$40K in PE funds does not, and the Authority is ready to use this funding to procure

engineering services for the project. The Authority will present the engineering contract to the Commission for review and approval.
